The Ministry for Communities, Territories and Infrastructure Development of Ukraine presents its compliments to the Ministry of Infrastructure of the Republic of Poland and addresses with the following.

As was previously reported, from February 2024, the "Electronic Border Crossing Queue" electronic system (hereinafter "eQueue") has been extended to all road border checkpoints (hereinafter BCPs) of Ukraine.

We kindly ask you to note that as part of the implementation of the "eQueue", our Ministry is gradually introducing the organization of crossing the border by buses at a specified slotted time. We would like to inform you that from September 2, 2024, such a procedure will be introduced at the following BCPs: Uhryniv – Dolhobyczów, Smilnytsia – Kroscienko.

The registration under the new procedure has started on August 30, 2024.

For each bus that moves on a **regular** route out of Ukraine, the carrier will have to reserve a time slot in the "eQueue" due to the corresponding schedule. **Irregular** bus carriers need to provide the permit number or the Interbus logbook number.

Taking this opportunity, the Ministry for Communities, Territories and Infrastructure Development of Ukraine renews the assurances of its highest consideration to the Ministry of Infrastructure of the Republic of Poland and expresses hope for further fruitful cooperation.
